In this contract, you will find a list of our essential beauty services:

Bride Practice Styling

*This should be scheduled 3 to 4 weeks prior to your wedding.
Bring everything you'll wear on your big day, such as your veil, jewelry, and so on.*

Bridal Hair Trial: \$150
Bridal Airbrush Makeup Trial: \$100

Wedding Day Hair / Makeup

*We'll recreate the look we achieved during your practice run.
Please remember that everyone in your wedding party is welcome to join us
for services on your wedding day.*

Bride Up-Do: \$125
Bride Airbrush Makeup: \$125
Bridal Party Up-Do: \$100*
Bridal Party Airbrush Makeup: \$100*

*Please note that the bridal party prices are per person, per service.

On-Location Service Fees

For those who need us to travel to their location, please schedule wedding services at least four months in advance. Travel fees are an additional cost to our regular services costs:

Within 15 miles: \$75 per stylist
Outside 15 miles: \$75 per stylist + \$1.00 per mile over 20 miles

Due to time, no blowouts will be available.
- Make sure your face is cleansed & moisturized prior to arrival to ensure your makeup application lasts.
- Any clients who get a spray tan prior to the event, agree not to have their face sprayed as it effects the airbrushed makeup. We will match the spray tan.
- Bring any pictures of makeup & hairstyles that you are interested in for the makeup artist & hairstylist to consider.
- Most importantly, please be on time. We hope to keep everything running on time as to make your special day as stress-free as possible!

2. **Photo Release.** The Client will allow use of their image for The Studio to use in advertisements in print, online and on social media.

Should the need to adjust or cancel any of the details listed above, we do ask that all changes be made 30 days prior to payment. If changes or cancellations are made within a 30 day notice, the entire cost of the canceled services will be placed on the credit card. I agree to pay the balance due the week of the wedding. Please note, we can only accept cash or check as payment for any services added on the day of the wedding, & must be made before any additional services are performed. In addition, I understand that no refund will be given for members of the wedding party who miss their appointment on the day of the event.
